1. To receive your 3-Year Limited Warranty, purchase a new Panasonic PT-AE8000U home theater projector from an Authorized Panasonic Reseller in the United States from January 1, 2015 – March 31, 2015. This cannot be combined with any other offer.
2. Return this completed form, including the serial number label, along with a copy of your invoice with the purchase price circled.
IMPORTANT: You must cut out and include the original label from the carton, which includes the UPC code, model number and serial number, or your registration cannot be processed.
3. Offer valid for purchase made from January 1, 2015 – March 31, 2015. All registrations must be postmarked within 30 days of purchase.
4. This offer is only available to the end user and original purchaser. No registration from re-sellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be accepted or acknowledged.
5. Product must be new and un-used. No B-Stock product allowed.
