2. Return this completed form, including the serial number label, along with a copy of your invoice with the purchase price circled.
IMPORTANT: You must cut out and include the original label from the carton, which includes the UPC code, model number and serial number, or your registration cannot be processed.
3. Offer valid for purchase made from April 1, 2017 – June 30, 2017. All registrations must be postmarked within 30 days of purchase.
