
Choose a location



Turn on your equipment

Plug in the projector.



Press the bower button on the projector or the **On** button on the remote control. The shutter opens and the bower light flashes blue, then stays on.



3 Follow the on-screen instructions to set up your projector. If you see a screen displaying 123, press **Enter** on the remote control to continue. Use the arrow buttons to select the correct image orientation and press **Enter**.






